



# Exhibitor Terms and Conditions



1. Destination ImagiNation and Exhibitor agree that all displays must be fully set up and operational by the Expo opening. No cases or packing materials of any sort may be brought in or out of the exhibition hall during show hours. Exhibitor also agrees to open and staff displays during show hours.
2. Exhibitor agrees that displays will not visually or physically disturb aisles or adjacent exhibitors, and Exhibitor agrees that hard walls will not exceed 8 feet in height without prior approval.
3. Exhibitor agrees to conform to all State of Tennessee Fire Department and the Knoxville Convention Center rules and regulations.
4. Exhibitor agrees not to sublet exhibit space or exhibit any merchandise other than that specified in the show contract. Exhibitor agrees that Destination ImagiNation reserves the right to reject, modify or restrict any exhibit.
5. Exhibitor agrees that space assignments may be changed by Management.
6. Exhibitor agrees that electrical wiring or installation shall be done only by the electrical contractor approved by Destination ImagiNation and Knoxville Convention Center.
7. Exhibitor will be provided breakfast and lunch, as well as refreshments and snacks in the Exhibitor Lounge, during normal show hours.
8. Exhibitor will be notified of show setup and breakdown hours by April 1, 2010 via e-mail.
9. Exhibitor agrees not to make undue noise or odor, use bright or hazardous lights, cause damage to the building or booth equipment or act in any manner deemed inappropriate by Destination ImagiNation.
10. Exhibitor agrees that no soliciting for business will be conducted in aisles or in other Exhibitor booths.
11. Exhibitor shall be liable for all damages which he/she may cause to the building, or otherwise in connection with his/her exhibit.
12. Exhibitor agrees that in an event due to warfare, strike, government regulation, public enemy or other cause that prevents the show or any part thereof from being held, Destination ImagiNation, in its sole discretion, shall determine and refund to the exhibitor his/her proportionate share of unused funds.
13. Exhibitor agrees that the serving of alcoholic beverages by Exhibitor is strictly forbidden at any and all Global Final events.
14. Exhibitor agrees that, except as otherwise specifically provided herein, this Agreement constitutes the entire Agreement between the parties, and supersedes all proposals, promotional materials, negotiations and understandings of any nature whatsoever. This agreement may be amended only by a written agreement signed by both parties.
15. Exhibitor agrees to assume all responsibility for loss, theft, destruction of goods or personal injury to him/herself, his/her employees, agents, representatives, or visitors, and shall indemnify, defend and save harmless Destination ImagiNation from any and all liability in connection with any and all of the above.
